

Requests for shortened business hours or temporary closure to restaurants, karaoke venues, and nightlife establishments that serve alcohol in Aichi Prefecture

To the owners of restaurants and karaoke venues in Aichi Prefecture

The Aichi Prefectural Government was requesting to shorten business hours to prevent further spread of infection to businesses in Sakae and Nishiki districts in Nagoya. A grant will be paid if these businesses complied with the requests.

This time, we expand the areas and extend the period on business restrictions.

Extension of restriction period

25 days starting from Friday, December 18, 2020, through Monday, January 11, 2021

*Previously, only Sakae and Nishiki districts in Nagoya were under business restriction from Sunday, November 29, 2020, through Friday, December 18, 2020.

Areas under business restrictions

All over Aichi Prefecture

*Until Thursday, December 17, 2020, certain areas of Sakae and Nishiki Districts in Naka-ku, Nagoya, had been subjected to business restrictions.

Details of the request

Business facilities subject to the request

Nightlife establishments such as so-called cabaret clubs or host clubs that serve food and beverage, bars or nightclubs that serve food and alcohol, and karaoke venues that serve alcohol

Shortened business hours

Open after 5:00 and close before 21:00

Grant amount

40,000 yen per day and maximum 1,000,000 yen to each business facility

Application method

Register your business in the list of “safety- and security-declared facility” on the Aichi

Prefectural Government website, and obtain and display the PR sticker and poster.

Necessary documents on provisional basis

1. Application form for the grant
2. Proof of business operation
3. Documents that prove shortened business hours
4. Documents for identification
5. Written oath
6. Documents to confirm your bank account
