

**[Extension] To those who operate business facilities that serve alcohol in Aichi Prefecture (April 1 through April 21)**

To prevent the further spread of COVID-19, the Aichi Prefectural Government has been asking business facilities that serve alcohol to shorten their business hours or temporarily close. A grant will be paid to those who complied with the request for shortened business hours or temporary close.

Business owners who complied with the request **from extended period of April 1 through April 21** may receive a grant.

**Period subject to request**

31 days starting from Monday, March 22, 2021, through Wednesday, April 21, 2021

**Grant amount**

20,000 yen per day per shop, and a maximum of 620,000 yen

**Areas subject to request**

Nagoya

**Eligible business owners**

Business facilities that serve alcohol

\*Restaurant business license is required.

### **Shortened business hours**

- Open after 5:00 and close before 22:00

\*Not eligible if regular business hours do not exceed 5:00 through 22:00 before the requested period.

### **Requirements**

- To comply with the “guidelines for each industry group”
- To register your shop as “safety- and security-declared facility” and display the PR sticker and poster issued by the Aichi Prefectural Government

### **Application method and period**

To be informed when the details are decided

### **Necessary documents on a provisional basis**

1. Application form for the grant
2. Written oath
3. Proof of business operation (copy of restaurant business license and final tax return form)
4. Documents that prove shortened business hours or temporary closure (copy of your website, or pictures of posters or flyers)
5. Documents for identification (copy of your residence card, and driver’s license or health insurance card)
6. Documents to confirm your bank account
