High School Tuition Support Fund

◎About the High School Tuition Support Fund

This system covers approximately 70 percent of the total number of households, and those identified as **eligible households** will be exempt from tuition fees for public high schools (repayment unnecessary).

The maximum free-tuition period is 36 months (48 months for part-time and correspondence course students).

Applications are required to take advantage of the system.

As a general rule, applications will be accepted from school entry and considered for approval based on a set of criteria. The households exempt from high school tuition fees, including those with children in their first year of high school, will undergo an income screening in July every year.

In principle, applications will need to be submitted online*. All households are advised to apply, via smartphone or PC, **regardless of whether or not they regard themselves as eligible.**

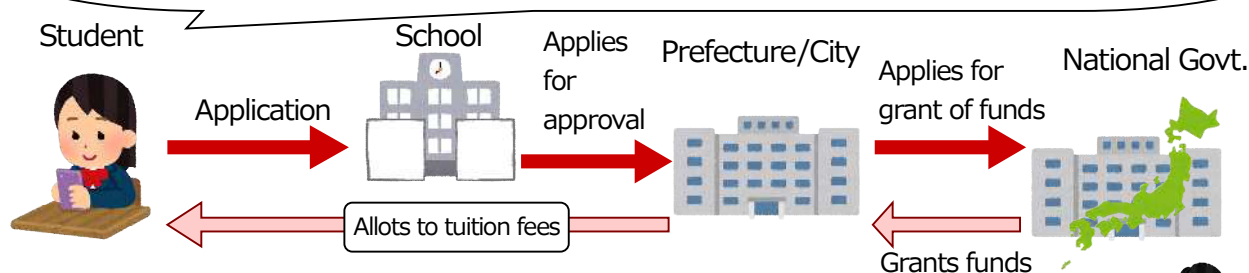
All the necessary information including your ID number and password, as well as registration method will be provided by your child's high school.

* If you are not able to apply online, please contact the office of the high school in which the student is enrolled.



If you enter your parent's or guardian's My Number information in the online application form, you do not need to submit any additional documents. Once approved by screening, you will not need to enter the My Number in the next screening in July.

【Eligibility criteria】

Municipal resident tax base x 6% – adjusted deduction	
*In ordinance-designated cities (e.g. Nagoya City), adjusted deduction x 3/4	
Less than ¥304,200	¥304,200 or more
Approved: No tuition charged	Not approved: Tuition charged

- Households with an annual income of less than approximately 9.1 million yen (assuming a family of four: two parents, one high school student, and one junior high school student) are eligible for this system.



The above income limitation is simply the standard and is subject to change based on the number of dependents, applicable deductions, and other conditions. Households eligible for this tuition support are determined based on their applications. Therefore, if you are not sure whether your household is eligible or not, you are advised to apply.

- As of March 2025. The system is subject to change.
- For the details of the municipal resident tax base and the amount of adjusted deduction of the municipal resident tax, please contact the government of the city to which you pay your resident tax.

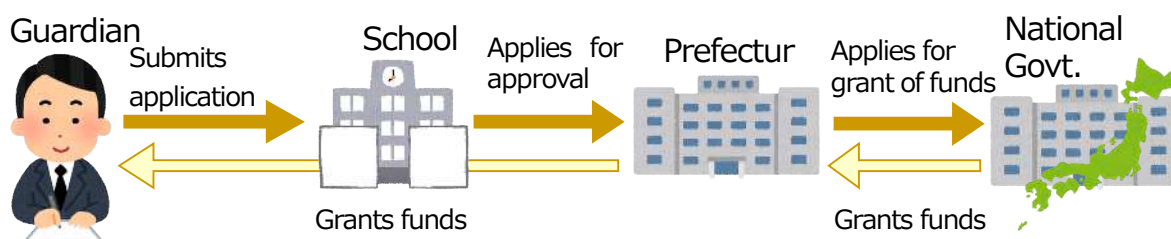

Aichi Prefecture High School Supplemental Scholarship Fund (Only for those eligible)

◎ About the Aichi Prefecture High School Supplemental Scholarship Fund

This fund provides grants for supplemental educational costs (expenses for study materials, school trip, etc.), apart from tuition fees, to all households receiving welfare benefits (occupational assistance) or all households exempt from paying prefectural resident tax and municipal graded income tax (repayment unnecessary).

Those who wish to receive assistance are required to submit an application. Application forms will be distributed by the schools to eligible candidates in July every year.

• Documents to be submitted to the office of the school in which the student is enrolled:

1. Application form
2. Taxation certificate

Original taxation certificate (a copy if you submitted the original one when applying for the High School Tuition Support Fund). If you wish to obtain a taxation certificate, please bring your passport or other personal identification document, seal, fee, and Attachment 1 on page 5 written in Japanese to your local municipal office.

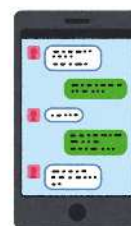
The documents in 1 and 2 must be submitted to the office of the school in which the student is enrolled by / / (: am/pm).
